You remain in control of funds; we don't execute withdrawals. Some features (e.g., derivatives- related modules) are unavailable in certain countries, including for U.S. retail users. Subscriptions auto- renew until canceled. Nothing here is investment advice.

1) Acceptance of Terms

By accessing or using the websites, apps, and related services (the "Service"), you agree to these Terms of Service (the "Terms"). If you do not agree, do not use the Service. We may update these Terms from time to time; continued use means you accept the updated Terms. We will post the effective date at the top and notify you when required.

2) Who we are

EasyBTC Technologies LLC ("**EasyBTC**", "we", "us") provides non- custodial automation and analytics software for crypto exchanges. Contact: **support@easybtc.me**. Our **Privacy Policy** explains how we process personal data: **/privacy**.

3) Eligibility & Geographic Restrictions

- You must be 18+ and have capacity to contract.
- You are responsible for ensuring the Service is permitted under the laws of your country and the terms of your exchange.
- Certain features (e.g., derivatives- related modules) are not available in some jurisdictions, including the United States for retail users. We enforce geo- blocking, self- declarations, and where required, eligibility checks. Do not attempt to circumvent

4) Accounts & Security

Register an account with accurate information and maintain the security of your credentials. You are responsible for activities under your account. Notify us promptly of any unauthorized access.

5) Non- custodial nature; Exchange API permissions

- The Service connects to your exchange accounts via API keys that you generate and control. You may revoke keys at any time in the exchange settings.
- We require **restricted scopes only** (e.g., read and trade where necessary) and do **not** request withdrawal permissions.
- You authorize the Service to place/cancel orders and read data within the scopes you grant, solely to operate the selected strategy or automation.
- You remain responsible for complying with your exchange's terms and settings, including margin, leverage, and risk controls.

6) Plans, Billing & Taxes

- Billing currency: USD. Payments are processed by Stripe; we do not store full card numbers.
- Subscriptions **auto- renew** at the end of each term unless you cancel before renewal.
- You can cancel anytime in your account; access remains until the end of the paid period.

- You are responsible for any taxes applicable to your purchases; where required, we will
 collect and remit indirect taxes (e.g., VAT/GST) based on your billing country.
